The participation fee for the choreographic laboratory must be paid in full by 15 DECEMBER, 2023 specifying in the header for payment: name, surname, INTERDANZA - CHOREOGRAPHIC LABORATORY

Regulation:

1. An audition for participation in the choreographic laboratory is not required; however, taking into account the pupil's age the participant is required to have a basic study of intermediate/advanced ballet.
2. Maestro Eriberto Verardi will hold a classical dance lesson at the first meeting, in order to identify the skill levels of the participants in order to assign the various roles.
3. Registration can be done directly by downloading the paper form, once completed, send to the e-mail address info@interdanza.it.

4. Documents required for participation:
 - registration form filled in and signed in all its parts signed (paper),
 - payment (bank transfer)

Note: Participants who have not submitted all the required documentation are not admitted to the choreographic laboratory.
5. The choreographic workshop will take place in Via di Popogna 50, at ASD Laboratorio di Danza e Movimento and in Via dei Cavalieri 69 at the DEA Dance School starting from the month of January. Participants will be promptly notified regarding the location and times of each weekend of the laboratory.
6. At the time of registration, a deposit of 100 Euro must be paid plus the compulsory registration fee of 10 Euro. The balance must be paid by 15 December 2023. The fee cannot be returned in the event of non-participation or withdrawal, nor can it be transferred or combined with that of other participants. The fee will only be refunded if the management is forced to cancel the event.
7. Costumes are the responsibility of the participant.
8. Travel, board and lodging expenses are the responsibility of the participant.
9. For minors, the consent form of their parents/tutors is mandatory.
10. The organization reserves the right to apply changes to the project if a sufficient number of participants has not been reached, or to make changes to the logistics of the event, if it deems it necessary, to ensure the proper execution of the activities. Any changes will be promptly communicated.
11. Interdanza reserves the right not to carry out the Interdanza project in the event of natural disasters. Participants will be issued a voucher valid for the following year.
12. The Arts4All Cultural Association declines all responsibility in the event of theft or damage caused to participants or their property during lessons and during the entire stay at the DEA Dance and Movement Laboratory and Dance School facility and is exempt from any civil liability and penalty relating to participation in the Interdanza project.
13. The Arts4All Cultural Association is relieved of any responsibility related to physical fitness of all participants and subsequent injuries.
14. By signing the registration form, the participant or (in case of a minor) the guardian declares to have read and approved the Interdanza regulation.
15. Medical Certificate: The participant declares to be in possession of a medical certificate certifying to be fit to carry out the indicated physical activity (certificate of sound and robust constitution issued within the 12 months prior to the start of the internship).
16. All participants will receive Interdanza certificate of participation.
